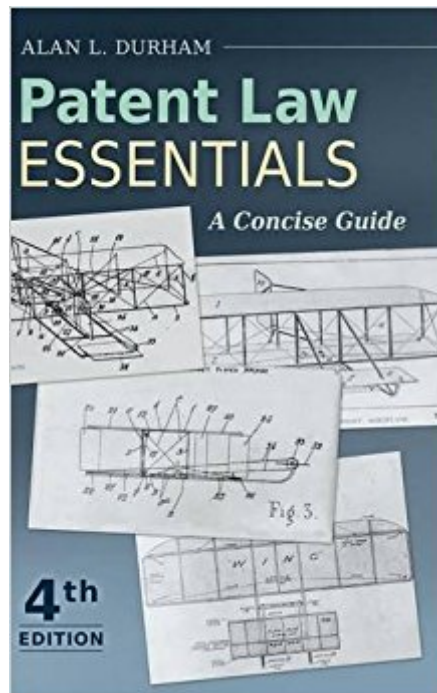

This book represents the best one-volume reference for beginners and experts interested in patent law. It is immensely helpful as a quick reference guide for materials that might be useful in legal proceedings. When I switched careers and went to work as a patent analyst in the patent group at my employer, my new manager gave me this book. I read it over a weekend for a survey of the topic, which was very helpful. As I settled into my new role, I reread the book and reinforced my own knowledge while filling in the gaps of certain topics (for example, continuation-in-part vs RCE). This book is an excellent primer for someone new to patent law and after a first read, it becomes a very valuable reference.
